TERMS OF REFERENCE FOR CLEANING AND HYGIENE SERVICES

1. INTRODUCTION

The South African Health Products Regulatory Authority (SAHPRA / The Authority) is the regulatory authority responsible for the regulation of health products intended for human and animal use, the conduct of clinical trials, as well as the licensing of manufacturers, wholesalers, and distributors of medicines and medical devices, radiation emitting devices, and radioactive nuclides.

The legislative mandates of SAHPRA are derived from the Medicines and Related Substances Act, 1965 (Act No. 101 of 1965), as amended (herein after referred to as "the Medicines Act"), and other relevant legislation, regulations, and policies.

In terms of the Medicines Act, the objectives of the Authority are to provide for the monitoring, evaluation, regulation, investigation, inspection, registration, and control of medicines, scheduled substances, clinical trials, medical devices, and radiation emitting devices, and related matters that are in the public's interest.

SAHPRA transitioned into a public entity on 1 February 2018. Previously, the Authority was known as the Medicines Control Council (MCC), a sub-programme of the National Department of Health (NDOH).

SAHPRA charges fees for various services rendered in terms of its mandate. These fees are gazetted, and applicants pay fees prior to submission of application. Payment received are allocated in a clearing account (unallocated) until matched to an application where it's added to the deferred income / income received in advance listing. Revenue is recognised on service rendered.

2. PURPOSE

SAHPRA invites licensed telecommunications service providers (holders of both Electronic Communications Services (ECS) and Electronic Communications Network Services (ECNS) licenses (hereafter referred to as "Service Providers") for implementation of MPLS or SD-WAN, Internet solution and Mobile Data for SAHPRA's main office in Pretoria and satellite office in Cape Town and Durban.

The contract period shall be for a maximum of thirty-six (36) months.

- 3.1 Implementation of a Wide Area Network (WAN), i.e., Multi- Protocol Label Switching (MPLS) network or Software Defined Wan (SD-WAN), Internet Services and Mobile Data.
- 3.2 Provide WAN connectivity through a secure MPLS/SD-WAN between three (03) SAHPRA Offices for a period of thirty-six (36) months:
 - Pretoria Head Office
 - Cape Town Branch Office
 - Durban Branch Office
- 3.3 Connectivity between Branch Offices should be via Head Office.

- 3.8 Provide SAHPRA with public IP addresses (20), security and flexibility allowing SAHPRA to internally host public facing services with ease through known standard protocols and ports such as websites, FTP etc.
- 3.9 Perform pre- and post-installation inspections to verify that installation requirements are met.
- 3.10 Provide infrastructure needed to maintain 99.99% uptime.
- 3.11 Make provision for redundancy and high availability on the core WAN network... This should be indicated clearly on what measures and controls will be taken and implemented.
- 3.12 Ensure software updates/upgrades (Router firmware & Line upgrade etc.) are performed on hardware at no extra cost to SAHPRA. All Upgrades/updates to be carried out in line with SAHPRA Change Control Policies.

A project schedule shall not be mistaken for a project plan.
- 3.18.3 The Service Provider shall assign a project manager to manage the project ensuing from the award of this bid as well as to manage the multi-disciplinary and multi- stakeholder project team that will be responsible for the implementation of the project. The Curriculum Vitae of all project team members shall be included in the bid documentation. Failure to abide by this will invalidate a bid.
- 3.18.4 The service provider must ensure that the required deliverables during the project implementation are provided to the client and demonstrate the achievement of the desired outputs or outcomes within the constraints of the contracted time and resources. A penalty of 15% of the contract ceiling price inclusive of VAT will be charged for each day the project is overdue.
- 3.18.5 The Service Provider shall be expected to establish a project management office in close proximity to the facility where the system will be piloted, tested, commissioned, or rolled out. Such costs shall be borne by the Service Provider.
